

Me England Privacy Policy

Our privacy policy will explain how we use the personal data we collect from you when you use our website.

1. What data do we collect?

Our company collects the following data:

- Personal Identification information (Name, address, email address, phone number, etc)

2. How do we collect your data?

You directly provide our company with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email
- Use or view our website via your browser cookies

3. How will we use your data?

Our company collects data so that we can:

- Process your order, manage your account
- Email you with special offers on other products we think you might like

We will not share your data with any other organisations for third party marketing.

4. How do we store your data?

Our company securely stores your data on a remote cloud server hosted by our website provider Wix.com. We will keep your personal identification information for 3 years. Once this period has expired (unless you have an existing active account with us) your data will be deleted by Me England.

5. Marketing

Our company would like to send you information about our products that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop our company from contacting you for marketing purposes. If you no longer wish to be contacted for marketing purposes please email admin@meengland.co.uk

6. What are your data protection rights?

Our company would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

- The right to access – you have the right to request from our company copies of your personal data. We may charge a small fee for this service.
- The right to rectification- you have the right to request that our company correct any information you believe is inaccurate. You also have the right to request our company to complete information you believe is incomplete.

- The right to erasure – you have the right to request that our company erase your personal data, under certain conditions.
- The right to restrict processing – you have the right to request that our company restrict processing of your personal data, under certain conditions.
- The right to object to processing – you have the right to object to our company’s processing of your personal data, under certain conditions.
- The right to data portability – you have the right to request that our company transfer the data that we have collected to another organization, or directly to you, under certain circumstances.

7. What are cookies?

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. When you visit our website, we may collect information from you automatically through cookies or similar technology.

9. What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- Functionality – our company uses these cookies so that we recognise you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first party and third party cookies are used.
- Advertising – our company uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. We may share online data collected through cookies with our marketing partners to tailor our advertising to you.

10. How to manage cookies?

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.

Our company keeps its privacy policy under regular review and places any updates on this webpage. This policy was last updated on 7th July, 2020.
